**Second Notice of Violation**

Dear Ms. Farr:

On September 17, 2013, the Tennessee Department of Environment and Conservation's Division of Solid Waste Management sent a Notice of Violation to you with a requirement to submit a Special Waste Application to the Division by September 27, 2013, although you have contacted the Division about the application, it has not been received as of October 17, 2013.

In addition, after speaking with Mr. Shane Ratcliff, of the Department of Agriculture, a deed notification form is required to be filled out and registered with the Roane County Courthouse. According to Mr. Ratcliff, evidence was found that animals were in fact buried on the property. The deed notification form is not a permit and no further burials shall take place on the property that is associated with the business located at your home. The burial site shall be completely covered with at least 2ft of dirt and stabilized to prevent anything from washing out. In addition, the site shall be prepared in such a way as not to allow wild animals to scavenge from it.


A Compliance Review Meeting is scheduled for **October 29, 2013, at 9:30 am.** The meeting will be held at the Knoxville Environmental Field Office located at 3711 Middlebrook Pike, Knoxville, TN. The purpose of this meeting is to provide you the opportunity to discuss the alleged violations and the steps you have taken or intend to take to bring the disposal site into compliance. Please bring a copy of the completed deed notification form that has been registered at the Roane County Courthouse and a copy of the Special Waste Application to the meeting. Please be advised that this matter has been referred to our Central Office Enforcement Section for review.

We again advise you that failure to comply may result in civil penalties up to \$5,000.00 per day for each violation.
