AFFIDAVIT

CASE NUMBER 3:15-MJ 1056

- I, Rebecca A. Bobich, being duly sworn, state the following information to be true to the best of my knowledge, information and belief:
- I am a Senior Special Agent (SSA) with the Bureau of Alcohol, Tobacco,
 Firearms and Explosives, United States Department of Justice and have been so employed since
 August of 1992. I am currently assigned to the Knoxville Field Office located in Knoxville,
 Tennessee.
- 2. As a result of my training and experience as a Special Agent for the Bureau of Alcohol, Tobacco, Firearms and Explosives, I have received specialized training regarding the investigation and enforcement of federal firearm and explosive violations and have conducted numerous investigations regarding individuals involved in illegal firearm/explosive activities. I have participated in hundreds of investigations involving federal firearms and violent crime offenses including violations of Title 18, United States Code, Section 922(g).
- 3. On September 21, 2015, Larry Dewayne WILLIAMS (hereinafter "the defendant") violated Title 18, United States Code, Section 922(g)(1). Except as noted, all of the information contained in this affidavit is either known to me personally or has been told to me by other law enforcement officials.
- 4. On September 21, 2015, at approximately 2030 hours, there was a shooting which occurred on Wakefield Road, Oak Ridge, Tennessee. The description of the vehicle involved in the shooting was that of a silver Infiniti sedan with damage to the rear area of the vehicle. At approximately 2221 hours, Oak Ridge Police Department (ORPD) Officer JB Elkins observed a

silver Infiniti sedan with damage to the rear of the vehicle, bearing TN registration tag number U6218Z, sitting at the light of W. Outer Drive and N. Illinois Avenue, Oak Ridge, Tennessee heading westbound. Officer Elkins pulled in behind the vehicle and checked the registration through dispatch. Dispatch advised that the tag came back to the defendant. Officer Elkins was also advised to use extreme caution with subject due to prior past history with law enforcement.

- 5. Officer Elkins attempted to conduct a traffic stop on the silver Infiniti. The suspect vehicle signaled as if to pull over and then accelerated and pulled away from Officer Elkins. During the pursuit, the suspect vehicle ran through a red light, was struck by a vehicle which then causing him to hit another vehicle and the suspect vehicle rolled onto its side and slid into the curb. When Officer Elkins approached the suspect vehicle it was empty and had caught on fire. He went back to his vehicle to get a fire extinguisher and to put out the fire. After attempting to put out fire, Officer Elkins had learned that the suspect fled on foot from the crash scene. Interviews were conducted and the witnesses all described the same thing. A black male, with dread locks, wearing black shirt and khaki pants had climbed out the driver side of the suspect vehicle while it was still sliding to the curb and ran into the woods.
- 6. When Officer Elkins looked into suspect vehicle for the driver, he observed a semi-automatic pistol laying in the suspect vehicle. Also in plain view was an AR-15 type firearm lying on the passenger floorboard. The suspect vehicle was secured and taken to Public Works until a search warrant was issued.
- 7. After the accident, Anderson County Sheriff's Office Acker arrived with his K9 and conducted a K9 track of the area. During that time, the K9 tracked to the back of the residence at 612 W. Outer Drive, Oak Ridge, Tennessee.
 - 8. A check of Oak Ridge Utilities database indicated that the utility subscriber at 612

- W. Outer Drive, Oak Ridge, Tennessee is Chelsey Lively. Chelsey Lively and the defendant are in a romantic relationship and cohabitating. The State of Tennessee Probation and Parole Officer Walter Cum reported that the defendant is currently on probation/parole and that the defendant has reported his address at 612 W. Outer Drive, Oak Ridge, Tennessee.
- 9. When ORPD Officers knock on the door to 612 W. Outer Drive Oak Ridge,
 Tennessee, the door was unsecured and came ajar. Officers announce their present with no
 response. Officers noted lights were on and television was operating. Officers then enter the
 home to clear it and check on the occupant's welfare. No one was found in the home. Officers
 observe in plain view hand gun cases and gun magazines. In addition, the officers noted what
 they believed to be the odor of marijuana from within 10 feet of the home. State search warrants
 were obtained for the residence and the suspect's vehicle.
- 10. During the search of the vehicle, two firearms, a loaded Mohawk Armory .223 caliber pistol, MA-15, serial number J103 and a loaded Armscor .45 caliber pistol, serial number RIA1477765 and a single round of 9mm ammunition were located in the vehicle.
- 11. During the search of the residence, approximately 7.72 ounces of suspected marijuana, approximately 2 ounces of suspected heroin, plastic baggies, a Triton digital scale, .45 caliber ammunition, .223 caliber ammunition, gun magazines and gun cases were recovered.
- 12. Chelsey Lively, the defendant's girlfriend, was located and interviewed on September 24, 2015. When questioned about the car wreck and the defendant she stated that the defendant had shown up at the house at the bottom of the steps. She asked the defendant what happened as she was helping him into the car and she stated that he was not saying much, but that he kept stating, "We gotta go" and "I don't know if I hurt the family". He also stated, "I don't know how I got out of the car. The car caught on fire and it flipped". She stated that she

pulled out of the driveway and went away from the cops and that he kept saying that his life was over that he's done. When asked if she had ever bought any guns before or if she knew how the defendant got his guns, she answered, "No".

- 13. I have reviewed the defendant's criminal history and the defendant has three prior felony convictions from the Criminal/Circuit Court of Anderson County, Tennessee. The convictions are Case Number A7CR0029 for one count of Possession of Cocaine with Intent to Sell (+.5), Case Number A9C01114 for one count of Possession of Cocaine with Intent to Sell (-.5) and Case Number A9C01070 for one count of Possession of Cocaine with Intent to Sell (.5).
- 14. The Armscor .45 caliber pistol, serial number RIA1477765 and all of the ammunition possessed by the defendant were manufactured outside the State of Tennessee.

 Therefore, they affected interstate commerce. Both the firearms and ammunition recovered in this case also meet their respective definitions under the federal law.

15. Therefore, based on all of the foregoing, there is probable cause to believe that on or about September 21, 2015, in the Eastern District of Tennessee, the defendant, having previously been convicted in a court of a crime punishable by a term of imprisonment exceeding one year, did knowingly possess, in and affecting commerce, a firearm and/or ammunition, in violation of Title 18, United States Code, Section 922(g)(1).
